Report to Council Village of Haines Junction Open Meeting April 22, 2020

RE: REVIEW OF BY-ELECTION POSTPONEMENT

Recommendation:

That Council review this report for information purposes and table the by-election review until their May 27, 2020, Council meeting.

Background

Council Member Courtney Quinn submitted her resignation which was accepted by Council Resolution at the January 22, 2020, Council Meeting. A by-election was scheduled with the Advance Poll on April 9, 2020, and the Regular Poll on April 16, 2020.

Given the COVID-19 situation, Council passed a motion at their March 25, 2020, meeting to send a letter to the Yukon Government requesting the by-election's postponement and to direct that this matter remain a standing item monthly on the Council agenda.

Bylaw #367-20, Bylaw to Repeal By-Election Bylaw No. 360-20, was adopted on April 3, 2020.

Current Status:

The Yukon Government declared a state of emergency on March 27, 2020, via Order-in-Council 2020/16. The Yukon Government issued Ministerial Order 2020/14 Civil Emergency Measures Health Protection Order on April 2, 2020, restricting movement and activity in the Yukon. Both of these orders remain in place and the potential impact of the pandemic on a by-election has not decreased.

Conclusion

Council by reviewing and tabling this report will exercise their oversight role for the by-election process.

Report to Council April 22, 2020

RE: PROCEDURAL BYLAW AMENDMENT # 1 NO. 368 – 20

Recommendation:

That Council review this report and, having approved the proposed amendment to include the phrase *renovation or destruction of Council*, proceed to Third Reading and Adoption of Bylaw Amendment Bylaw No. 368 – 20.

Background:

The procedural bylaw states that the Presiding Officer of a council meeting is required to be physically present in Council Chambers.

It is proposed, due to the current COVID-19 epidemic and to provide for other eventualities, that this requirement be changed so that, in extraordinary circumstances, the Presiding Officer would not be required to be physically present.

The Yukon Municipal Act requirements for advance notification of a change to the Procedural Bylaw have been complied with.

It was noted in the discussion of the Bylaw at the April 8, 2020 Council Meeting that if Council Chambers was destroyed it could not longer be used.

Current Status:

The proposed Bylaw 368-20 to amend the Council Procedural Bylaw is attached.

An additional phrase (**bold font**) has been added to the Bylaw

The person who will be the meeting's Presiding Officer may, in extra-ordinary circumstances such as the **renovation or destruction of Council Chambers**, earthquake, wildfire, blizzard, or local epidemic, participate electronically.

Conclusion:

Council, by reviewing this report and then making such changes as deemed desirable to the attached Bylaw No 368 -20 will make it possible for the Presiding Officer to, in extraordinary circumstances, lead Council Meetings without being physically present in Council Chambers.

THE VILLAGE OF HAINES JUNCTION

Bylaw #368-20

A bylaw of the Village of Haines Junction to amend Council Procedural Bylaw #352 – 19

WHEREAS Section 210 of the Municipal Act, requires the Council of the Village of Haines Junction to make by bylaw rules governing its procedures including rules respecting the calling of council meetings; the appointment of members of council to council committees; and, any other matter that relates to the efficient administration of council's decision-making process or council meetings.

NOW THEREFORE, the Council of the Village of Haines Junction in open meeting assembled, hereby ENACTS AS FOLLOWS:

Short Title:

This Bylaw may be cited as the "Council Procedural Bylaw #352-19 Amendment #1 Bylaw".

Provisions

Sub-article 11.3 which states:

The person who will be the meeting's Presiding Officer may not participate electronically

Is replaced in its entirety with the following Sub-article 11.3

The person who will be the meeting's Presiding Officer may, in extra-ordinary circumstances such as the renovation or destruction of Council Chambers, earthquake, wildfire, blizzard, or local epidemic, participate electronically.
